

# MINUTES OF MEETING

## **DISABILITY REVIEW BOARD**

August 19, 2015

The Disability Review Board conducted a regularly scheduled meeting on Wednesday, August 19, 2015 in Room 213 of Stratford Town Hall, 2725 Main Street, Stratford, CT pursuant to notice duly posted.

- I. CALL TO ORDER: At 6:45 p.m. by Chairman Dr. Frank Scifo.  
BOARD MEMBERS IN ATTENDANCE: Dr. Renee Rickard-Casey, Kurt Ahlberg, Esq. and Dr. Frank Scifo  
OTHERS IN ATTENDANCE: HR Director Ron Ing, HR personnel Susan Barksdale, Asst. Town Attorney John Florek
- II. APPROVAL OF MINUTES — Minutes of November 20, 2013 and special meeting of May 6, 2015. Upon a motion by Dr. Rickard-Casey, seconded by Atty. Ahlberg, the foregoing minutes were unanimously approved.
- III. OLD BUSINESS

*(tabled during meeting of May 6, 2015)* Application of Stuart Wierzbicki (Fire Dept.) for disability Pension NOT in the line of duty. (Forwarded from Pension Board meeting of March 23, 2015.)

Attorney Ahlberg motioned and seconded by Dr. Rickard-Casey to take the application of Stuart Wierzbicki off the table. The motion passed unanimously.

Attorney Ahlberg motioned and seconded by Dr. Rickard-Casey to enter into executive session to discuss confidential medical information relating to applicant for disability pension, Stuart Wierzbicki, with executive session to include Dr. Renee Rickard-Casey, Kurt Ahlberg Esq., Dr. Frank Scifo, Town of Stratford HR Director Ron Ing, HR personnel Susan Barksdale, and Asst. Town Attorney John Florek. The motion carried unanimously.

Chairman Scifo recessed the regularly scheduled meeting in room 213 at 6:48 p.m. Executive Session included: Dr. Renee Rickard-Casey, Kurt Ahlberg, Esq., Dr. Frank Scifo, Town of Stratford HR Director Ron Ing, HR personnel Susan Barksdale, and Asst. Town Attorney John Florek. Executive session ended and the regularly scheduled meeting reconvened at 7:06 p.m.

Chairman Scifo noted that Attorney Ahlberg motioned to end executive session, Dr. Rickard-Casey seconded the motion and passed unanimously.
