1. **CALL TO ORDER** – Chairman Chris Tymniak made a motion to call the meeting to order at 2:35PM. Motion was approved by Mr. McCarthy and seconded by Sgt. Gugliotti. Motion passed unanimously.
2. **APPROVAL OF MINUTES** – Mr. Tymniak made a motion to approve the minutes of the regular meeting held on October 20, 2016. Motion was approved by Mr. McCarthy and seconded by Sgt. Gugliotti. Motion passed unanimously by a vote of 4-0.

3. TABLED ITEMS

- a. Discussion of State proposal to reconstruct East Broadway intersection with Ferry Blvd

Mr. Chris Tymniak made a motion to remove this item from the table and open it up for discussion. Mr. McCarthy approved this motion seconded by Sgt. Gugliotti. Mr. Tymniak requested that the crosswalk remain the same. Motion passed unanimously by a vote of 4-0.

- b. 1166 Barnum Ave & 443-445 King Street – Request a review for the zoning application.

Mr. Chris Tymniak made a motion to remove this item from the table and open it up for discussion. Mr. McCarthy made a motion to approve this item, seconded by Sgt. Gugliotti. The motion passed unanimously by a vote of 4-0.

4. NEW BUSINESS

- a. 111 Research Dr. – Request for “No Parking” signs in front of this location.

Mr. McCarthy stated this is a dead-end, cul-de-sac and industrial area. This is a very active service area with several cars parked on the road. Mr. McCarthy made a motion for “No Parking” on the entire street with a tow-away zone. Sgt. Gugliotti seconded this motion. The motion passed unanimously by a vote of 4-0.

- b. 430-432 Wiklund Ave. – Request for “No Parking during Snow Emergency” sign.

Mr. McCarthy made a motion to table this item pending further investigation by the Police Department, seconded by Sgt. Gugliotti. Motion carried by a vote of 4-0.

- c. Bruce Ave and Stratford Ave – Request to adjust the timing of the traffic light.

Mr. Tymniak stated this is a State road and should be referred to the State Traffic Division. Mr. McCarthy made a motion to approve this item seconded by Sgt. Gugliotti. Motion carried by a vote of 4-0.

5. ADJOURNMENT

Mr. Tymniak made a motion to adjourn. Mr. McCarthy made a motion to approve the request to adjourn seconded by Sgt. Gugliotti. Motion passed unanimously. The meeting adjourned at 2:56 PM.
