**6.2.1 RESOLUTION ADOPTING TOWN OF STRATFORD COMPLETE STREETS POLICY**

**WHEREAS**, Stratford Planning Commission has approved the Stratford Complete Streets Policy to promote safe streets through design, education and enforcement in all of its transportation network, as well as enhance quality of life and economic vitality; and

**WHEREAS**, the Stratford Plan of Conservation & Development specifically recommends the adoption of this policy to advance the positive social, economic, and environmental quality goals.

**NOW, THEREFORE LET IT BE RESOLVED BY THE TOWN COUNCIL OF STRATFORD, CONNECTICUT** that the Stratford Complete Streets Policy shall be utilized, to the extent practical and appropriate, in connection with the planning, design and implementation of all transportation and Complete Streets improvements initiated after the adoption hereof.
